Narrative by Cienega, Anthony

At the time of this incident, I was wearing a department issued AXON Body camera. Footage from my camera will be uploaded to the department's digital evidence management system per Kent Police Department policy.

On 6/9/2026 around 1710 hours, I was dispatched to a transient male DOA inside a trailer at Valley Mobile Manor located at 856 Central Ave S, in the City of Kent. Dispatch notes advised that the reporting party, FUENTES PULIDO, ALFREDO confirmed via WA DOL had last seen the deceased around 1300 hours on 6/8/2026. Notes stated ALFREDO only knew the deceased as MOHAMMED.

I arrived and met fire on scene, they did not attempt to render aid. Fire determined the time of death as the last time the deceased was seen, 1300 hours on 6/8/2026.

I met with ALFREDO and his daughter FUENTES MERCADO, JOSELYN confirmed via WA DOL at unit 97. ALFREDO state that he knew the deceased for around seven (7) years, he would help him out with food and water. Since the deceased did not have a place to stay, ALFREDO would let him sleep in his red Tahoe bearing WA LIC# CCH9742 that was parked in the units carport. Both ALFREDO and JOSELYN stated that they had last seen the deceased around 1300 hours on 6/8/2026.

The Tahoe was only accessible via the driver and driver side rear door. The deceased was located in the rear storage area of the vehicle. Inside, the deceased appeared to be curled up in a ball, with a hoodie obscuring his face. There was a black backpack located behind the deceased that appeared to be his.

I searched the backpack to attempt to identify the deceased. While searching the backpack, I found a folded paper from DSHS with the name SHINWARY, MOHAMMAD and a DOB 12-27-1986. In the search I found glucose testing strips and a glucose reader. A small glass pipe with residue and two (2) lighters were also discovered.

I inspected the body for signs of trauma or foul play. I was able to confirm the deceased was SHINWARY, MOHAMMAD via a comparison of WA DOL. While rolling over MOHAMMAD, I observed a glass pipe in his left hand and a rolled up paper currency in his right hand. There also appeared to be blood around his nose and mouth, with a stream of vomit on the pillow he was using.

JOSELYN stated that he believed MOHAMMAD used drugs off and on but had been clean for the past three (3) months. She also mentioned that MOHAMMAD was just released from Yakima Jail last week. She mentioned it was possibly related to warrants he had.

ALFREDO stated he discovered MOHAMMAD around 1645 hours, when he entered the Tahoe to retrieve a charger. They believed he was gone prior to discovering him. ALFREDO attempted to shake MOHAMMAD awake. Once he realized MOHAMMAD might be dead he called 911.

I called the King County Medical Examiner who advised they be responding to the scene. Death Investigator Mike Guerrero arrived on scene and provided case #26--1538.

Case Closed.
